### **Job Summary:**

Responsible for training and ensuring clinical staff are performing procedures according to SOPs and other training materials/requirements. Conducts evaluation and measurement of staff member understanding and compliance with all clinical procedures.

### **Essential Duties and Responsibilities:**

- Reports to the Training Supervisor.
- Supports Clinical Operations Manager, Clinical Staff Manager and Clinical Research Coordinators and other assigned managers in ensuring Spaulding Clinical SOPs and study specific protocols are followed appropriately by clinical staff.
- Oversees process ownership by staff members to guide annual review of SOPs, WI's and internal auditing of procedures throughout the year.
- Coordinates the training of newly hired clinical research employees to ensure training is completed in a timely manner in conjunction with the Clinical Staff Manager and Staffing Coordinators.
- Tracks the progress of the training program and evaluate cost, efficiency and effectiveness
  of the program, under the direction of the Clinical Staff Manager.
- After assigned training is completed by a staff member, supports ongoing training in conjunction with the Clinical Staff Manager, by facilitating performance improvement plans and assignment of retraining.
- Provides ongoing review, analysis, and suggested improvements for clinical training program.
- Maintains awareness t of SOPs, Good Clinical Practice (GCP), Good Documentation Practice (GDP), ICH guidelines, state and national laws and ethical standards.
- Readily accepts responsibility and is accountable for assigned and delegated responsibilities.
- Maintains knowledge of company goals in order to assist department in reaching those goals.
- Responsible to develop and present training in a professional manner.





- Responds with appropriate level of urgency to issues raised by staff, prioritize importance, and resolve issue or delegate as appropriate.
- Mentors and trains clinical staff in order to promote growth of each individual, whether in a training capacity or in order to master a set of skills.
