# Job Summary:

Under general supervision, the Laboratory Assistant performs specimen processing, receives and sorts specimens and performs computer data entry. Will staff and perform test analysis per training and scope, following all CLIA, FDA, and OSHA regulations. Functions as a liaison between the PK Laboratory, Clinical Laboratory, and internal CPU customers. This role will report to the Technical Supervisor/Consultant and will perform daily task direction, as required per laboratory business needs.

# **Essential Duties and Responsibilities (may include):**

- With supervision, ensures that clinical trials are conducted according to protocol requirements by utilizing the following techniques & procedures.
- Trains to and performs (with supervision) tasks such as:
  - PK or Clinical Laboratory tube labeling
  - performance and documentation of CLIA-waived or EUA testing, per training and scope of work
  - ensures that specimens received into PK or Clinical Lab are properly labeled and suitable for testing. Resolves specimen identification and/or requisition problems and clarifies requests
  - processes specimens for testing, including aliquoting, while maintaining proper specimen identification
  - enters and verifies test requests into the laboratories' computer system to allow for analysis and timely turn-around-time for results
  - o and inventorying supplies in laboratory or study areas,
  - o answers and screens telephone calls
  - receives and sorts specimens and assists with detailed specimen handling; packages and tracks specimens for transport and performs specimen storage and retrieval
  - o scanning, saving, and/or filing of documents,
  - o organizing and sorting PK or Clinical Laboratory samples,





- o PK Lab "Runner" duties,
- o technological entry of needed laboratory data
- performance of study events following training and proficient competency assessment,
- Other Clinical Pharmacology tasks on this level, as assigned
- Reviews Study Specific Trainings and applicable protocols for a thorough understanding of the study procedures, as they apply to their role and ensures that Delegation of Authority/Training Log for each study is completed in a proper and timely manner, if indicated.
- Keeps abreast of SOPs, Good Clinical Practice (GCP) and ICH guidelines, state and national laws and ethical standards, as trained and delegated.
- Observes and maintains all HIPAA, OSHA, CLIA and Exposure Control (Bloodborne Pathogens) regulations and Emergency Response as required by applicable training.

- Participates in quality assurance of clinical research projects and initiates the need for same as it impacts on clinical practice.
